Ladies and Gentlemen:

On behalf of the Town of Hamden, Haley & Aldrich, Inc. (Haley & Aldrich) is pleased to submit this quarterly Progress Report (No. 20) describing the actions the Town of Hamden has taken to date to comply with relevant requirements outlined in Connecticut Department of Environmental Protection (CTDEP) Consent Order No. SRD-128, Section B (5). Progress Report No. 20 covers the timeframe from 1 January 2008 through 31 March 2008.

WORK COMPLETED DURING REPORTING PERIOD

- In January 2008, Haley & Aldrich assisted Halloran & Sage with preparing a letter to CTDEP requesting an extension for submittal of the Remedial Action Plan for Rochford Field and Mill Rock Park.
- In February 2008, Haley & Aldrich responded to an information request from Leggette, Brashears & Graham.
- In mid-March 2008, Haley & Aldrich met with The Town of Hamden, Halloran & Sage and The Regional Growth Partnership to discuss the "Neighborhood Revitalization Plan". Also discussed was how remedial concerns could impact design.
- In late March 2008, Haley & Aldrich assisted The Town of Hamden, Halloran & Sage and The Regional Growth Partnership to understand costs associated with select conceptual design elements.

The next scheduled quarterly Progress Report will be due on 30 June 2008.


RESPONDENT AND PREPARER CERTIFICATIONS
