Ladies and Gentlemen:

On behalf of the Town of Hamden, Haley & Aldrich, Inc. (Haley & Aldrich) is pleased to submit this quarterly Progress Report (No. 21) describing the actions the Town of Hamden has taken to date to comply with relevant requirements outlined in Connecticut Department of Environmental Protection (CTDEP) Consent Order No. SRD-128, Section B (5). Progress Report No. 21 covers the timeframe from 1 April 2008 through 30 June 2008.

WORK COMPLETED DURING REPORTING PERIOD

- In mid-April 2008, Haley & Aldrich met with The Town of Hamden and Halloran & Sage to discuss the "Neighborhood Revitalization Plan". Also discussed was how remedial concerns could impact design.
- In April through early June 2008, Haley & Aldrich assisted The Town of Hamden, Halloran & Sage and The Regional Growth Partnership to understand costs associated with select conceptual design elements.
- In June 2008, Haley & Aldrich assisted LBG with drum characterization/disposal from the temporary storage area behind the former middle school.

The next scheduled quarterly Progress Report will be due on 30 September 2008.


