WORK COMPLETED DURING REPORTING PERIOD

- In late July 2007, Haley & Aldrich participated in a conference call with the Hamden Regional Growth Partnership to discuss environmental and geotechnical work completed to date in order to better determine potential future uses for the former Hamden Middle School site.
- In early August 2007, Haley & Aldrich responded to a request for information from the CTDEP environmental subcontractor LEA.
- Down-To-Earth, LLC attended NAC meetings on 23 August and 20 September 2007.

The next scheduled quarterly Progress Report will be due on 31 December 2007.


RESPONDENT AND PREPARER CERTIFICATIONS
