- On 10 October and 7 December 2006, Down-To-Earth, LLC attended Hamden Middle School reuse planning meeting and prepared a summary report.
- On 30 October 2006, Down-To-Earth, LLC attended CTDEP public meeting.
- During October/November 2006, Haley & Aldrich provided comments to the CTDEP Newhall Remedy Selection Plan.
- During December 2006, Down-To-Earth, LLC began series of discussions with CTDEP in order to better facilitate NAC requests for information.
- Responded to CTDEP staff requests for additional information.


The next scheduled quarterly Progress Report will be due on 31 March 2007.


